Reward	Eligibility Requirements	Reward Amount
Haikou Annual Top Ten Industrial Enterprises	Where an assessment is conducted on enterprises with an annual total industrial output value of at least 100 million yuan, a total R&D investment of no less than 10 million yuan, and an increase in industrial output value that is not lower than the average growth of the industries citywide in the previous year, and a remarkable profitability, and enterprises whose comprehensive rankings in six indicators (internal R&D investment, total R&D investment, the proportion of total R&D investment to total sales revenue, industrial output value, industrial output value growth rate, and tax payment in the assessment year) with weights of 2:1:2:2:1:2 are among top 10 will be rewarded.	Each of eligible enterprises will be recognized by the government of Haikou via circulating a notice, awarded the title of “Annual Advanced Industrial Enterprises”, and granted with a reward of 100,000 yuan.
R&D Support for New Industrial Enterprises	Where the fixed asset investment of a newly registered industrial enterprise reaches 100 million yuan (inclusive) or above.	Within 3 years from the commissioning date of each project, a reward will be given at 10% of the total fixed asset investment of the project every year, which in no case will exceed 3% of the enterprise’s total industrial output value of that year.
Enterprise Growth Reward	For enterprises that realize profits and over 20 million yuan of industrial output value and make over 5 million yuan of R&D investment.	A growth reward will be granted at 2% (3% for pharmaceutical enterprises) of the increase in the output value of the year over the peak value of the last three years, and each enterprise will receive a maximum reward amount no more than its total R&D investment of that year.

Enterprise Scale-up Reward	For enterprises whose annual total industrial output value reaches 500 million yuan, 1 billion yuan, 2 billion yuan, 3 billion yuan, 5 billion yuan, 8 billion yuan or 10 billion yuan for the first time in a year.	A one-time reward of 300,000 yuan, 600,000 yuan, 1.2 million yuan, 1.8 million yuan, 3 million yuan, 4.8 million yuan and 6 million yuan will be granted respectively to the enterprise in that year.
Implementation of Transformation and Upgrading Strategy	For industrial enterprises that are encouraged to increase investment in technological transformation and have made a total fixed asset investment of 20 million yuan (after tax) or above in technological transformation projects, capacity expansion projects and environmental protection projects, or an equipment investment of not less than 5 million yuan.	A one-time subsidy will be granted at 3% (5% for pharmaceutical enterprises) of the total fixed asset investment (excluding land payments) upon the completion and commissioning of each project, and each enterprise will receive a maximum amount of 50 million yuan for each project.
	For industrial enterprises which invest in software such as automatic management system used for intelligent manufacturing.	A subsidy will be given at 5% of total investment upon the software is put into use, and each enterprise will receive a maximum of 50 million yuan for each software.
Implementation of Brand Development Strategy	For industrial enterprises that newly obtained the title of China Well-known Trademark in a year.	A one-time reward of 500,000 yuan will be granted in the year.
	For industrial enterprises newly awarded the title of Product of Geographical Indication in a year.	A one-time reward of 100,000 yuan will be granted to each product in the year.
	For industrial enterprises which are encouraged to strengthen quality system construction and have passed the certification of ISO9001, ISO14001, OHSAS18001 or ISO45001	A one-time incentive subsidy of 20,000 yuan will be granted to each certification passed.
	For industrial enterprises which lead (or preside over) the preparation (or revision) of international, national and industry standards.	A reward of 400,000 yuan, 200,000 yuan and 100,000 yuan will be granted respectively for each international, national and industry standard in the year when the standard is released.
	For enterprises whose product standards implemented meet or	A one-time reward of 50,000 yuan will be granted to each standard in the

Reward for Implementation of Green Development Strategy	For enterprises included in the national and provincial circular economy pilots.	A one-time subsidy of 300,000 yuan and 200,000 yuan will be granted, respectively.
	For enterprises that have passed national and provincial clean production audits.	A one-time subsidy of 300,000 yuan and 200,000 yuan will be granted, respectively.
	To encourage enterprises to produce energy-saving products, for enterprises whose products have been included in the national or provincial promotion catalog of energy-saving products.	A one-time reward of 500,000 yuan and 200,000 yuan will be granted, respectively.
Support for the Introduction of Professional Technical Talents by Enterprises	For employees with the intermediate or senior professional and technical title certificates issued by the human resources departments of Hainan Province, who have paid the basic pension insurance in Haikou and contracted to work for two years or longer in enterprises that have an annual gross industrial output value of 100 million (inclusive) yuan or above, a total R&D investment of more than 5 million yuan, and an actual tax payment of more than 5 million yuan.	A subsidy of 3,000 yuan will be granted to each employee with an intermediate professional title every year, and a subsidy of 6,000 yuan will be granted to each employee with a senior professional title every year. If the industrial output value is 100 million yuan (inclusive) to 500 million yuan (exclusive), the number of rewarded employees shall not exceed 5% of the total number of employees in each enterprise; if the industrial output value is 500 million yuan (inclusive) to 1 billion yuan (exclusive), the number of rewarded employees shall not exceed 10 % of the total number of employees in each enterprise; and if the industrial output value reaches 1 billion yuan (inclusive), the number of rewarded employees shall not exceed 15 % of the total number of employees in each enterprise.
Subsidy for Transportation Expenditures	For industrial enterprises with an annual total industrial output value of over 100 million yuan,	A subsidy will be granted at a certain percentage of the annual transportation expenses (excluding

If the total industrial output value is 100 million yuan (inclusive) to 500 million yuan (exclusive), the subsidy will be granted at 10% of the annual transportation expenses; if the total industrial output value is 500 million yuan (inclusive) to 1 billion yuan (exclusive), the subsidy will be granted at 15% of the annual transportation expenses; and if the total industrial output value reaches 1 billion yuan (inclusive), the subsidy will be granted at 20% of the annual transportation expenses.
